As requested by the Fire Rescue Blue Ribbon Committee, staff from the Finance Department has put together the attached summary of costs incurred for the Fire Rescue Bond program. We have reviewed that schedule and made several adjustments.

We did not audit, nor examine in-depth all of the individual expenses posted to the various project accounts. Rather, we limited our work to reviewing the categories and descriptions of the expenditures and journal entries posted to the project accounts, using professional judgment to evaluate the appropriateness of the charges.

Since the discussion at the November 3rd Fire Rescue Blue Ribbon Committee meeting, we've expanded and refined our analysis. The observations below reflect the inclusion of additional engineering charges, and the removal of other charges that we have subsequently determined are appropriate.

We observed the following during our review:

1. The schedule did not include the portion of the costs for Fire Stations 53/88 and 47 that were funded through contributions from the General Fund and the Airport Fund. That amount comes to \$5.2 million and is shown in our adjusted total.
2. Engineering charges were improperly allocated to the Fire Rescue Bond Fund. Through September 7, 2016, those charges amounted to \$983,937. That sum will increase as charges are posted for the remaining periods in fiscal year 2016. While the project cost

for the stations must capitalize those costs under Generally Accepted Accounting Principles (GAAP), they should have been funded by the General Fund, not the Fire Rescue Bond Fund. We recommend that the City Manager take steps to reimburse the Fire Rescue Bond Fund for the amount of allocated engineering charges.

As part of our Audit Workplan for the upcoming year, it is our intent to conduct a closeout audit of the total construction costs for one of the more recently completed stations.
