

THIRD EXTENSION TO AGREEMENT

THIS IS A THIRD EXTENSION TO AGREEMENT, made and entered into this 1~~st~~ day of April 2010 by and between:

CITY OF FORT LAUDERDALE, a municipal Corporation of the State of Florida, (Hereinafter referred to as "CITY")

and

CORZO CASTELLA CARBALLO THOMPSON SALMAN, P.A. (C3TS), a Florida corporation, (hereinafter referred to as "CONSULTANT")

WHEREAS, the City Commission of the City of For Lauderdale, Florida at its meeting of June 20, 2006, authorized the proper officials by motion to execute an Agreement between CONSULTANT and CITY authorizing the performance of services in connection with Agreement for BRIDGE DESIGN CONSULTING SERVICES – 262-9313 CONTINUING CONTRACT; and

WHEREAS, Section 6.1 of the Agreement authorizes renewal for Three (3) successive one-(1) year terms upon mutual consent of the parties; and

WHEREAS, on January 6, 2009 by motion, the City Commission authorized the proper City officials to execute an Extension to Agreement, to extend services in connection with Agreement for Civil/Structural Engineering Bridge Design to June 19 2010; and

WHEREAS, CITY wishes to retain CONSULTANT to provide, and CONSULTANT desires to provide, contracted professional consultant services to CITY for an additional one (1) year period until June 19, 2011, utilizing the contract prices of the original Agreement; and

WHEREAS, on February 2, 2010 by motion, the City Commission authorized the proper City officials to execute this Third and Final Extension to Agreement to extend services under said Agreement until June 19, 2011;

NOW, THEREFORE, the parties hereto, in consideration of the mutual covenants, agreements, terms, and conditions contained herein, do agree as to the following:

Section 1. The foregoing recitals are true and correct and are made a part of this Third Extension to Agreement.




