# 2. Parcel 2 - Zeley Aviation - Construction Amendment to Lease Agreement

Staff recommends approval of a Lease Amendment for Zeley Aviation, Inc., Parcel 2, to extend the construction improvement deadline to July 31, 2015.

**Motion** was made by Mr. Moody and seconded by Mr. Kerney to support staff's recommendation. In a voice vote, motion passed unanimously.

## 3. Parcel 8AB - KC FXE - Construction Amendment to Lease Agreement

Staff recommends approval of a Lease Amendment for KC FXE, Parcel 8 AB, to extend the construction improvement deadline to October 31, 2015.

Mr. Kerney stated he may have a voting conflict because he had been in negotiations with them to rent hangar space for his flight school, which didn't pan out, therefore it doesn't look like they're moving forward (see conflict of interest form).

Vice Chair O'Malley had a question concerning operations; asking about the reason for the increase in the Heliport operations from last year. Mr. James responded saying that it could have been a couple of months where we had more traffic than in the previous year.

Mr. Campion of Banyan Air Services questioned the type of aircraft that was involved in the recent Alert III and Mr. James responded that it was a Cheyenne. On another matter regarding the Alert III, Mr. Helyer alerted the Board of the feelings of an unnamed author in an editorial, of a private publication called Oakland Park City News, commenting "how many crashes are we going to have to expect to live through".

Ms. Leonard updated the Board on Schlitterbahn stating that we are in the middle of the 30-day comment period, which, was posted on the Federal Registry by the FAA on May 20<sup>th</sup> and we should hear back from the FAA by June 20 with the conclusion. If there are no public comments that need to be addressed, we will move forward.

There being no further business before the Board, the meeting adjourned at 1:52 p.m.

The Airport's existing Master Plan was developed to provide for future airfield and nonairfield development options for 5 year, 10 year, and 20 year periods. The Master Plan was initiated in 2007 and approved by the Federal Aviation Administration (FAA) in 2010. Development of a Master Plan is required by FAA and Florida Department of Transportation (FDOT) per grant assurances and to maintain grant eligibility.

Fort Lauderdale Executive Airport staff proposes to update the current Master Plan in order to establish and communicate the City's mission, vision, organizational values, goals, and future action plans to guide and optimize the operation of Executive Airport. The new Master Plan would review the business environment influencing Airport activity; assure that the operation of the Airport is compatible, environmentally sound, financially feasible, and provide guidance for its ongoing operations and management in a manner that balances the needs of the aviation and surrounding communities.

The development of the Master Plan will include participation by the Aviation Advisory Board (AAB) and a Technical Advisory Group (TAG) to make recommendations to the staff and City Commission regarding the best alternatives for the successful continued improvement of the Airport. The TAG will consist of representatives of the AAB, Airport tenants, the community, FDOT, and local economic development agencies. The services to be included as part of the update include, but are not limited to:

- Analysis of the Airport's strengths, weaknesses, opportunities and threats
- Development of the City's goals and objectives for the Airport
- Forecast of aviation demand for 5, 10, and 20 year periods
- Existing conditions and needs assessment
- Development of operational enhancement scenarios to optimize efficiency of Airport facilities
- Development of an updated Airport Layout Plan
- Environmental and financial planning to verify implementation and feasibility
- Development of Final Plans/Technical Report
- Facilities Implementation plan

Staff has negotiated Task Order No. 4, in an amount not to exceed \$515,380.65, with HDR Engineering, Inc., the Airport's Consultant Engineers to provide the above services. Both the FAA and FDOT have reviewed and approved the Task Order and fees. It is anticipated that the Master Plan process will take 12 months to complete.

The Florida Department of Transportation executed a Joint Participation Agreement (JPA) in the amount of \$400,000 representing 80% of the estimated costs to provide an updated Master Plan. The remaining funding is budgeted in the project's fund balance, as well as, through a budget amendment in the amount of \$12,304.55 to complete the funding for the task order.

#### **Staff Recommendation:**

Staff recommends approval of Task Order No. 4 with HDR Engineering, Inc., in the amount of \$515,380.65.

The Airport's current Master Plan update recommends that a perimeter loop road be constructed on the east side of the airfield to minimize vehicle/equipment crossings at the approach end of Runway 27. Currently vehicles on the north side of the Airport cross Runway 27 in order to relocate equipment to areas south of Runway 27. These crossings affect Air Traffic Control Tower operations and airfield traffic, increasing the possibility of unauthorized incursions. The construction of the new road will serve to minimize runway crossings and enhance safety of airport operations.

Design of this project was completed in April and advertised on May 13, 2015. Bids were opened on June 10, 2015 with a total of nine bids being submitted. The lowest, responsive bidder was JMS Construction Services of Plantation, FL with a bid in the amount of \$449,125.00. This amount is less than the Engineer's estimate of \$474,219.70. We have reviewed the bids with respect to the Engineer's estimates and other competitive bids and found the unit price and reference checks on this company to be satisfactory. Funds for this contract award are available from the project fund balance.

#### **Staff Recommendation:**

Staff recommends award of the contract to the low responsive bidder, JMS Construction Services of Plantation, FL in the amount of \$449,125.00 for the construction of the East Perimeter Loop Road.

	Commerce Ltd

Cypress Commerce Ltd. (CCL) leases Lots 23 & 24 (Exhibit 1) in the Airport Industrial Park (AIP) at the Fort Lauderdale Executive Airport as a result of an Assignment of Lease in 1994. Lots 23 & 24 consist of 4.9 acres (213,840 sq. ft.) of non-aviation property and have been improved with the construction of two single story office service facilities totaling 60,000 square feet.

The original Lease commenced in 1985 and has a term of 50 years, expiring in 2035 with an option to extend for an additional 35 years. The Lease payments are \$142,360.68 per year and are adjusted every five years using the Consumer Price Index (CPI) method. The next adjustment period is October 1, 2015.

CCL is currently in default of the Lease Agreement for not paying property taxes (\$146,896.62) to Broward County for the 2014 annual billing cycle. On April 7, 2015 Airport staff issued a Notice of Default letter to CCL advising of the unpaid property taxes. Upon receipt of the letter, CCL representative Mr. R. Bowen Gillespie called to advise that the property taxes would be paid by May 31, 2015. A Lease Default letter was issued to CCL on May 7, 2015 in accordance with the Lease Agreement for failure to comply with the Lease Agreement. On June 15, 2015 Mr. Gillespie was notified of the Lease termination, at which time he advised that he was waiting to receive a call from the Broward County Tax Collector's Office for the total unpaid balance.


Additionally, CCL is also currently in default of the Lease Agreement for outstanding Code Enforcement violations for performing work without submitting permits with the City's Department of Sustainable Development (DSD). On April 6, 2015 Airport Staff issued a Notice of Default letter to Mr. Gillespie for the Code violations. The Code violations have not been corrected; therefore a Lease Default letter was issued on May 7, 2015 advising Mr. Gillespie of the Lease Agreement obligations to comply with City government regulations.


Given the extent of time provided to Mr. Gillespie to correct these issues, it is unlikely that the unpaid 2014 annual Broward County tax bill and outstanding Code violations will be resolved. Therefore, termination of the Lease Agreement for Lots 23 and 24 with Cypress Commerce Ltd. shall begin along with initiating legal action to recover the past due taxes and other outstanding costs associated with the Lease.

#### Staff Recommendation

Staff recommends that the City Commission authorize the City Manager to terminate the Lease for Lots 23 and 24 with Cypress Commerce Ltd. in accordance with the Lease Agreement.

SUBJECT:	Noise Compatibility Program Update

#### Noise Monitoring Terminal (NMT) Replacement and Relocation

The City's vendor verified that Florida Power & Light does not have electrical power that is available at the selected site. Alternate locations in the same area were considered. However, these locations were rejected because loud industrial noise was emitted from nearby buildings making the locations unsuitable.

After considering other sites, the decision was made to locate the monitor near its present location within the City of Oakland Park and seek approval from the City of Oakland Park to install the monitor/utility pole in a right-of-way on N.W. 9<sup>th</sup> Avenue, along the roadway's grass swale.

#### Noise Exposure Map Update

HMMH has requested the FAA to preliminarily review the required large drawings before HMMH prints the drawings. Once the City receives, the final documents from HMMH, then the City will submit the Noise Exposure Map Update study to the Federal Aviation Administration (FAA) for their determination. We will provide the Board with an update when the final determination is made by the FAA.

#### Nighttime Jets

There were no jet departures over 80 dB at night between 10:00 p.m. and 7:00 a.m. during the month of May 2015.






