



Project Overview

The Florida Department of Transportation (FDOT) has awarded a \$15 million contract to Construct Group Corp. for the construction of sidewalks, multi-use pedestrian paths, and bicycle lanes along 45 roadways in Broward County. Construction began February 2, 2015 and will be completed in Fall 2018. This project is part of a larger \$100 million investment from the Broward Metropolitan Planning Organization (MPO) to provide bicycle, pedestrian, and public transportation access throughout the Broward region. Project Improvements

Construction in Fort Lauderdale is expected to begin February 13, 2017 and be completed in summer 2017.

SW 30 Ave. from SW 2 Ct. to Broward Blvd.

- Constructing a 5-foot concrete sidewalk along both sides of the corridor, filling in the missing gaps

SW 28 Terr. from SW 4 St. to Broward Blvd.

- Constructing a 5-foot concrete sidewalk along both sides of the corridor

NW 22 Ave. from north of Broward Blvd. to east of NW 21 Terr.

- Constructing a 6-foot concrete sidewalk along the west and north sides of the corridor

NW 18 Ave. from Broward Blvd. to Northfork Riverfront Park

- Constructing a 5 to 6-foot concrete sidewalk and curb and gutter along the east side of the corridor to the existing sidewalk at the park property

NW 14 Ave. from Broward Blvd. to NW 4 St.

- Constructing a 5-foot concrete sidewalk along both sides of the corridor, filling in the missing gaps

SW 12 Ave. from SW 4 St. to Broward Blvd.

- Constructing a 5-foot concrete sidewalk along both sides of the corridor, filling in the missing gaps

SW/NW 11 Ave. from Waverly Rd. to NW 4 St.

- Waverly Road to Broward Blvd.—Constructing a 5-foot concrete sidewalk along the west side of the corridor
- Broward Blvd. to NW 4 St.—Constructing a 5-foot concrete sidewalk along both sides of the corridor, filling in the missing gaps

SW 8 Ave. from SW 2 St. to Broward Blvd.

- Constructing a 5-foot concrete sidewalk along both sides of the corridor, filling in the missing gaps
- Sidewalk may meander
- There will be no sidewalk on the east side from SW 1 St. to Broward Blvd.

Traffic Impact

Single lane closures can be expected Monday through Friday between 9 a.m. and 4 p.m. and Sunday through Thursday between 9 p.m. and 5 a.m.
