#### Las Olas Beautification Plan

#### May 2017

Las Olas Isles was one of the most beautiful, picturesque streets in America, however the years have taken its toll on the corridor and there is a strong desire and groundswell of support that it is vital to our community to restore its reputation and make all that travel, on that road, smile at its beauty.

As a result of this groundswell of support within the community, Godart Florida Real Estate Investments, PNC Bank, Patrick McTigue, and Corporate Insurance Advisors (Mark Schwartz) have pledged design funding for EDSA, an internationally renowned planning, landscape architecture and urban design firm, founded and located in Fort Lauderdale; to examine potential improvements along the Las Olas Boulevard corridor. The study area is from approximately NE 15th Avenue on the west side to the west side of the Las Olas Intracoastal Bridge on the east. We call this area the Gateway Las olas area, connecting Retail Las Olas to the Beach Las Olas. The intention of these improvements is to create a cohesive pedestrian and vehicular roadway corridor that functions, is safer for all modes of traffic and has an aesthetic that the residents and community can be proud of.

In early Fall, surveys went out to all the Las Olas Associations, and their members, as well as City of Fort Lauderdale personnel, asking them what they considered were the most important issues on Las Olas Blvd. the results were as follows:

- Slow down the cars
- Make it pedestrian friendly for walking and bicycles
- Make the streetscape aesthetically pleasing, with lots of shade

EDSA took this information and created a plan based on this information. They looked at Las Olas Blvd. and focused on the north side, since that is where all the open water view vistas are. Their idea was to create a lineal park, stretching from the eastside of the bridge to just east of 15<sup>th</sup> Street.

In order to get the space they needed for the northside, they did the following:

- Eliminated the on street bike lanes
- Narrowed each of the 4 lanes of traffic from 12 feet to 10.5 feet
- Moved the median slightly to the south
- Narrowed the median slightly

As a result, the following is a description of the proposed improvements (please keep in mind that this is only the concept, which can be fine tuned):

#### Northside:

- Starts with a curb and then a landscape buffer between the street and the lineal park
- 2 lanes for bicyclists, roller bladers, and pedi cabs
- Another landscape buffer
- Meandering pedestrian side walk, called Canal Walk that will have trellises and benches for people to sit and enjoy the views.


#### Southside:

• Currently, the only buffer between the street and the side walk is a patch of grass. As a result of the plan, the area separating the sidewalk from the street will be widened to 5 feet to allow a landscape buffer of trees between the sidewalk and the street.

East of where the median ends (near Chima and Gas Station):

• The plan still allows for continuity to continue the lineal park to the bridge.

All of this will create a signature, pedestrian friendly environment that will encourage people to walk, run, and bicycle from the beach into Retail Las Olas.

#### Las Olas Boulevard (the "jewel of Fort Lauderdale) Streetscape Conceptual Master Planning

Las Olas Isles was one of the most beautiful, picturesque streets in America, however the years have taken its toll on the corridor and there is a strong desire and groundswell of support that it is vital to our community to restore its reputation and make all that travel, on that road, smile at its beauty.

As a result of this groundswell of support within the community, **Godart Florida Real Estate Investments, PNC Bank, Patrick McTigue,** and **Corporate Insurance Advisors** have pledged design funding for EDSA, an internationally renowned planning, landscape architecture and urban design firm, founded and located in Fort Lauderdale; to examine potential improvements along the Las Olas Boulevard corridor. The study area is from approximately NE 15<sup>th</sup> Avenue on the west side to the west side of the Las Olas Intracoastal bridge on the east. The intention of these improvements is to create a cohesive pedestrian and vehicular roadway corridor that functions, is safer for all modes of traffic and has an aesthetic that the residents and community can be proud of.

The sponsors named above have formed an organization, named Las Olas Isles Beautification Plan, LLC. F. Thomas Godart will be the official officer of the organization. At the onset of the study, EDSA prepared a survey so that they could collect information from the residents that live near or on Las Olas Boulevard. The intention of this data collection is to have a greater understanding of the community's wants and desires related to the improvements along the Las Olas Boulevard Corridor. Now with this information, EDSA can initiate the planning and design process to produce a preliminary conceptual master plan. Then based on feedback from the community and the City of Fort Lauderdale, EDSA will finalize the Conceptual Master Plan.

Attached to this document are the results of the survey that was sent out. In summary the survey indicated that:

- Pedestrian safety is a priority with a score of 3.96 out of 5
- Vehicular safety is also a priority with a score of 4.05 out of 5
- Traffic calming measures should be utilized to slow traffic down, with a score of 3.42 of 5
- There is concern about sea level rise and the King tides, with a score of 4.56 out of 5
- The order of prioritization of modes of travel are as expected, Vehicles with the highest priority, followed by Pedestrians, then Bikes and last other forms (skateboards, rollerblades, runners/joggers)

- Infrastructure improvements is also important, with a score of 4.3 out of 5
- However, wider sidewalks were not as important with a score of 2.45 out of 5, just a little below a neutral vote of 2.5
- Bike lanes are desired, but only with a score of 3.19 out of 5
- Landscape improvements are desired with a score of 4.32 out of 5
- Overall aesthetics is important with a score of 4.49 out of 5
- 93% of the respondents (57 people) were full time residents, with only 7% being part time residents


In summary, the two most important elements of the project, according to the survey results are infrastructure improvements (dealing with sea level rise) and aesthetics, which as planners opens up a lot of opportunities for creating an updated, safe corridor that all can enjoy.

# Q1 Is the pedestrian safety along the corridor a priority?



# Q2 Is the vehicular safety along the corridor a priority?











# Q7 Are including wider sidewalks along the corridor a priority?



# Q8 Are including bike lanes along the corridor a priority?



# Q9 Are landscape improvements along the corridor a priority?





Las Olas Boulevard is the gateway to and from the beach and the business district. The importance of the aesthetics and visual impact of the corridor cannot be overstated. Consideration should be given to decorative themed street signage and signalization, replacement of the existing street lighting fixtures (the current ones are deteriorating due to being made partially of cast aluminum which is corroding in the salt air environment. Also they don't make much of a visual statement) with substantial cast iron or high grade aircraft quality aluminum street light fixtures (perhaps the city saved the cast iron ones they removed from A1A that could be repurposed on Las Olas. Although they may rust and need repainting they will last hundreds of years), visually impressive mature landscaping (consider replacing the Royal Palms in the medians with mature canary island date palms and relocate the existing royal palms to the swales. The coconut palms could be relocated to the beach), the remaining landscaping should be native and compliment larger statement landscaping. Understory plants such as coontie and saw palmetto and flowering plants that are low on maintenance. Groupings of cabbage palms with naturally curvy trunks could be considered as well in the Swales.
