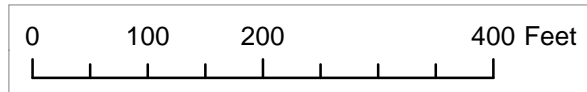

- The sign shall be posted at least fifteen (15) days prior to the date of the public hearing.
- The sign shall be visible from adjacent rights-of-way, including waterways, but excepting alleys.
- If the subject property is on more than one (1) right-of-way, as described above, a sign shall be posted facing each right-of-way.
- If the applicant is not the owner of the property that is subject of the application, the applicant shall post the sign on or as near to the subject property as possible subject to the permission of the owner of the property where the sign is located or, in a location in the right-of-way if approved by the City.

That if the relief requested is granted by the Board, the applicant must secure a building permit to implement the relief requested within one hundred eighty (180) days of the entry of the final order or the Board, or within such lesser time as the Board may proscribe and that failure to procure the necessary permits within the time so proscribed shall render the variance or special exception null and void;
5. That if the Board denies the request for relief, then no additional application for the same or substantially the same relief may be entertained by the Board within two (2) years of the date of entry of the final order of denial.

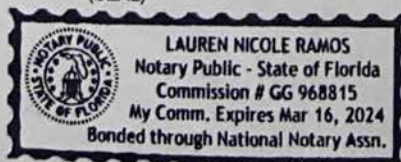



- (a) Under the power and right to zone areas in which the sale of alcoholic beverages is prohibited or permitted, it is hereby established that the sale of alcoholic or intoxicating beverages under authority of a state license issued under the provisions of F.S. §§ 563.02(1)(b), 564.02(1)(b) and 565.02(1)(a) and (b), other than special licenses for hotel and restaurant bars, is prohibited in any place of business located within five hundred (500) feet from any established church, or public or private school, other than a pre-kindergarten school, nursery school or day care center, or adult education center, measured from the main normal public entrance of the alcoholic beverage establishment to the nearest point of the church or school property used as part of such facility along public thoroughfares by the shortest route of ordinary pedestrian traffic. Whenever such a state license has been lawfully procured and thereafter a church or school is established within a distance otherwise prohibited by this section, the establishment of such church or school shall not be cause for the revocation of the state license or prevent the subsequent renewal of same.

The Pita Xpress kosher Mediterranean Restaurant (“Pita Xpress”) is an approved restaurant located in the Galt Ocean Mile neighborhood having the street address 3558 N Ocean Blvd. The Pita Xpress Restaurant seeks approval to serve alcoholic beverages incidental to its principle service of food. Specifically, a special exception to the City’s liquor distance separation ordinance Section 5-27 which requires a separation of 500 feet between an establishment and a church or school. The Pita Xpress Restaurant is located approximately 71 feet from one of the Chabad Lubavitch Of Greater Fort Lauderdale’s properties; 136 feet from another of the Chabad’s properties; and 243 feet from the Shalom Pre-school operated by the Chabad. In fact, the Applicant property is owned under the Ruach, Inc. entity which is also a Chabad property – the present tenant - Pita Xpress’s landlord. As such, the Chadab is in full support of this Special Exception and has provided the attached letter of support.

Section 5-27.b specifically provides that for restaurants where the sale and service of alcoholic beverages is incidental to the sale and service of food that the Board of Adjustment is authorized to grant special exceptions to the distance requirements where the Board finds that such special exception will not be contrary to the public interests.

Pursuant to Section 47-24.12.A.5. of the ULDR a special exception shall be granted upon demonstration by a preponderance of the evidence of all of the following criteria are met - which we believe are more than met by this application:

- a. Whether the proposed development or use meets the requirements for a special exception as provided by the ULDR.

Restaurants are permitted in the zoning district and the Pita Xpress Restaurant is licensed as a restaurant with the State Division of Hotels and Restaurants and the City. Section 5-27 requires a distance of 500 feet between an establishment and a church or school and allows restaurants that do not meet the distance requirement to seek a Special Exception to allow such sales. Section 5-27.b expressly provides for a special exception to serve alcoholic beverages within 500 feet of a church or school, when such is incidental to the sale and service of food. In this case, The Pita Xpress Restaurant’s primary business is a kosher Mediterranean style restaurant and therefor meets the requirements for the requested Special Exception.

b. Granting of the special exception shall not be incompatible with adjoining properties or the surrounding neighborhood or otherwise contrary to the public interest.

The Pita Xpress Restaurant is located in the middle of the commercial area between Oakland Park Blvd. and NE 36th Street. The zoning for this commercial area is Community Business (CB) which permits restaurant uses. This commercial area is home to several other commercial uses that serve alcoholic beverages including Greek Islands Taverna; The Etna Rosso Ristorante; Nick's Italian Restaurant; and many establishments in the North Beach shopping area. These businesses are primarily neighborhood serving uses. The City has conducted a distance measurement to the closest church and school in the area and has determined that the Pita Xpress location is approximately 71 feet from one of the Chabad Lubavitch Of Greater Fort Lauderdale's properties; 136 feet from another of the Chabad's properties; and 243 feet from the Shalom Pre-school operated by the Chabad.

Since the property is located on a primarily commercial corridor surrounded by commercial and business uses granting of this Special Exception to allow the Pita Xpress Restaurant to serve a glass of kosher wine or beer incidental to its primary use of food service is consistent with the existing uses and compatible with this commercially zoned area. Further, the granting of this Special Exception will not impact or conflict with the surrounding neighborhood as the use primarily serves the area residents and will be enjoyed by all. Further still, the Chabad is in full support of this application and many of its members frequent the Pita Xpress.

The granting of this Special Exception will allow patrons who frequent the Pita Xpress Restaurant for food to enjoy a refreshing alcoholic beverage with a unique dining experience. Pita Xpress's business will continue to be based upon the sale of unique Mediterranean influenced fare. The introduction of this incidental sale of alcohol is not contrary to the public interest, nor will it negatively impact its immediate neighbors.
