SUBJECT: JGCC RFQ Responses

The Unified Direct Procurement Authority (UDPA) approved the issuance of a Request for Qualifications (RFQ) for the Joint Government Center Campus (JGCC) on March 9, 2021 (Regular Meeting Item No. 65). The deadline for Developer teams to submit an RFQ response was today, April 21, 2021 at 2:00 pm EST. We are pleased to report that we received five (5) full RFQ responses. Staff will continue tomorrow organizing the RFQ response material received. In the coming days we will deliver to your offices a copy of each team's non-confidential submittal. The financial information, which is quite voluminous and in most cases submitted as confidential, will be reviewed by KPMG and FASD.

After County and City staff and our consultants review the RFQ response material submitted, we will create an informational matrix that will summarize the information received. This will be delivered to your offices at least two weeks prior to the next UDPA meeting. You will also receive an individual briefing on the information prior to the next UDPA meeting. One final note regarding the RFQ responses. We received a sixth partial response from Provident Resources Group, providing only information about their organization. Provident made it clear that they were not submitting qualifications in order to serve as a Developer in the traditional sense, but instead to offer their qualifications to serve as a nonprofit partner with the City/County and the chosen Developer team to secure cost-effective financing. While the submission is not responsive to the RFQ, we will nonetheless have it reviewed by KPMG and FASD.
