Re: Settlement of Claims – May 2021

In compliance with Section 2-151 of the Code of Ordinances of the City of Fort Lauderdale with regards to settlement of claims, please find attached a spreadsheet of liability and workers' compensation claims settled for \$100,000 or less.

The list includes the department, claim number, accident (injury) date, closed date, claim type, amount paid and description. The spreadsheet also documents amounts recovered from other parties (i.e., where the City was not at fault) during the past month.

In summary, in the month of May, there were 16 claim settlements totaling \$158,512.75 and 20 claim recoveries in the amount of \$53,559.37.
