Subject:	Broward Commuter Rail and the New River Rail Crossing

The Florida Department of Transportation (FDOT) and Broward County are conducting a Project Development and Environment (PD&E) study for the Broward Commuter Rail from the planned Brightline station in Aventura to the Palm Beach County line. The PD&E study includes the New River passenger rail crossing which originated from the 2019 FDOT Feasibility Study that identified four New River passenger rail crossing options including a 21' bascule bridge, a 56' bascule bridge, an 80' fixed bridge, and a tunnel.

Over the past 15 years, FDOT and Broward County envisioned a countywide commuter rail system that could connect with Palm Beach and Miami-Dade to create a regional commuter rail system through the densely populated coastal cities located along the Florida East Coast Railway corridor. With the passage of the Broward County Transportation Surtax in 2018, project development progress on the Northeast Corridor commuter rail segment in Miami-Dade and renewed interest from the host railroad, the vision has advanced, and the two entities executed a Memorandum of Understanding in 2021 for the future rail service.

The current PD&E study, which started in early 2021, is reviewing the entire commuter rail system in Broward County and the New River rail crossings. FDOT will be hosting a series of public kick-off meetings for the PD&E study as identified below:

- 1. <u>August 30 (1:00pm) Virtual Elected Officials/Agency Kick-off Meeting</u> The meeting will have an open house, followed by a presentation, and a question/answer session. FDOT sent the meeting information directly to your office.

ABOUT THE STUDY

The Florida Department of Transportation (FDOT) District Four and Broward County are performing a PD&E Study for the Broward Commuter Rail (BCR) along the Florida East Coast (FEC) Railway from Aventura in Miami-Dade County to Deerfield Beach in Broward County.

FDOT and Broward County have executed a Memorandum of Understanding (MOU) to continue efforts to improve mobility in the region. The scope of the BCR Project PD&E is to develop and analyze alternatives for commuter rail service along the Florida East Coast (FEC) Railway corridor from Aventura to Deerfield Beach. The corridor is owned by Grupo Mexico, who operates the rail freight service in the corridor. Brightline operates inter-city rail in this corridor, and has a passenger service easement within the FEC corridor right of way. The study is being conducted in coordination with many parties that have an interest in the FEC corridor. County is Miami-Dade also studvina the implementation of commuter rail service in the FEC corridor for the segment from Downtown Miami to a proposed station in Aventura, known as the Northeast Corridor.

The BCR is a 27-mile segment of this commuter rail service that will include the necessary rail, signaling, safety and communications improvements, and passenger stations and amenities connecting to existing and planned local and regional transit service. Six potential stations will be studied and evaluated within the study limits.

The BCR PD&E Study will include a new rail crossing at the New River for passenger service through Downtown Fort Lauderdale. The existing railroad bridge will remain in place for exclusive use by freight rail.

WHAT IS A PD&E STUDY?

A PD&E Study is FDOT's procedure for complying with the National Environmental Policy Act (NEPA) of 1969, and associated federal and state laws and regulations. During this phase, FDOT performs preliminary engineering, evaluates the projects impacts to the social, cultural, natural, and physical environments, completes interagency coordination, and engages the public. Public involvement is a key aspect throughout the life of a project. The objectives of a PD&E Study is to support decisions concerning if, where, and what should be built to address the identified transportation needs.




Why it's done:

- Evaluate project feasibility, alternatives and potential environmental impacts (natural, physical, social, and cultural)
 - Comply with federal and state environmental laws
 - Required to secure federal regulatory approval and funding

What it involves:

- Conducting preliminary engineering
- Evaluating options to enhance, avoid, minimize, or mitigate potential environmental impacts
- Coordinating with stakeholders, federal, state, and local agencies
- Engaging the public in evaluation of the alternatives project development
- Select a preferred alternative for the design phase once funding is identified
