## Re: NIMS Incident Command System Certifications and Tracking in Log

Maintaining Certification Compliance with the Federal Emergency Agency's (FEMA) National Incident Management System (NIMS) is of paramount importance for the City of Fort Lauderdale. The FEMA NIMS certifications and the accurate tracking of each is a requirement for FEMA reimbursement. Additionally, the certifications provide staff with essential training for working through emergencies.

All City employees are required to have NIMS certifications that correspond to their positions and/or management levels. The online (Independent Course Study) ICS100, 200, 700, and 800 courses must be completed within six months of hire or promotion date. The G300 and G400 certifications are required to be completed by City staff within a year of being assigned to the Emergency Operations Center (EOC), promoted, or moved to a new management level.

Completed courses must be entered into the tracking log by each department's designated NIMS coordinator. Please see the table below for required FEMA certifications.


The G300 and G400 courses are offered by the State as, in-person only, three-day sessions. A wait period of 90 days is required between each session and courses must be taken in order. City staff requiring these certifications should refer to their NIMS coordinator to obtain information on fulfilling these requirements.


