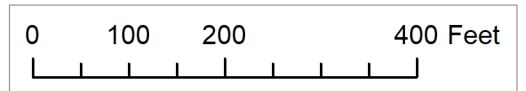

CRITERIA: Applicant must demonstrate a unique hardship attributable to the land by proving by a preponderance of the evidence for all of the following criteria. 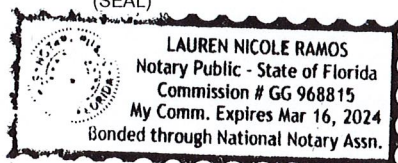

1. In order to be entitled to the relief requested in the application an affirmative vote of a majority plus one of the Board of Adjustment is required;
2. That in granting the relief requested, the Board of Adjustment is limited to the authority vested in the Board by the ULDR and that the Board may not grant the relief requested unless the applicant proves all the criteria specified in the ULDR have been met;
3. That the granting of relief by the Board does not exempt the applicant or owner of record from the responsibilities of obtaining all applicable permits or approvals as may be required by law for both new and existing structures;
4. That if the relief requested is granted by the Board, the applicant must secure a building permit to implement the relief requested within one hundred eighty (180) days of the entry of the final order or the Board, or within such lesser time as the Board may proscribe and that failure to procure the necessary permits within the time so proscribed shall render the variance or special exception null and void;
5. That if the Board denies the request for relief, then no additional application for the same or substantially the same relief may be entertained by the Board within two (2) years of the date of entry of the final order of denial.

Special Exception Request:

Code of Ordinances Section 5-27 – Distance of Establishments from Church or School

The owner of the property located at 3414 N Ocean Boulevard (the “Property”) respectfully requests a Special Exception from the City of Fort Lauderdale for a 2COP to allow the sale of alcoholic beverages on the Property. Code of Ordinances Section 5-27 – Distance of Establishments from Church or School provides for a distance of 500 feet from establishments that serve alcoholic beverages and churches or schools. The Property is 349 feet from Chabad Lubavitch.

Sushi Song has been a welcome neighborhood restaurant in Fort Lauderdale since 2019. The owners of Sushi Song have created a New York-style ambiance mixed with the exotic and sultry flavors mimicking South Florida’s nightlife. The experience in Sushi Song allows patrons to enjoy Fort Lauderdale’s beautiful weather while engaging their taste buds with exotic flavors in a fun and neighborhood-friendly atmosphere.

Pursuant to Section 47-24.12.A.5. of the ULDR a special exception shall be granted upon demonstration by a preponderance of the evidence that the following criteria are met - which we believe are more than met by this application.

a. Whether the proposed development or use meets the requirements for a special exception as provided by the ULDR.

Sushi Song is a restaurant, which is a permitted use in the Community Business district (“CB”). Section 5-27 requires a distance of 500 feet between an establishment and a church or school and allows restaurants that do not meet the distance requirement to seek a Special Exception to allow such sales. Section 5-27.b expressly provides for a special exception to serve alcoholic beverages within 500 feet of a church or school, when such is incidental to the sale and service of food. In this case, Sushi Song’s primary business is a New York Style sushi spot, which meets the requirements for the requested Special Exception.



b. Granting of the special exception shall not be incompatible with adjoining properties or the surrounding neighborhood or otherwise contrary to the public interest.

Sushi Song is located in the middle of the commercial area along Ocean Boulevard. This commercial area is home to several other commercial uses that serve alcoholic beverages including Greek Islands Taverna; The Etna Rosso Ristorante; Café Vico; and many establishments in the commercial area. These businesses are primarily neighborhood-serving uses. The City of Fort Lauderdale has conducted a distance measurement to the closest place of worship, and it was determined that Sushi Song is approximately 349 feet from the Chabad Lubavitch of Greater Fort Lauderdale.

Since the property is located on a primarily commercial corridor surrounded by other commercial uses granting this Special Exception will allow Sushi Song to serve a glass of wine or beer incidental to its primary use of food service – which will be consistent with the existing uses and compatible with this commercially zoned area. The introduction of this incidental sale of alcohol is not contrary to the public interest, nor will it negatively impact its neighbors.

Granting of this Special Exception application is respectfully requested.

Sec. 5-27. - Distances of establishments from church or school.

(A) Under the power and right to zone areas in which the sale of alcoholic beverages is prohibited or permitted, it is hereby established that the sale of alcoholic or intoxicating beverages under authority of a state license issued under the provisions of F.S. §§ 563.02(1)(b), 564.02(1)(b) and 565.02(1)(a) and (b), other than special licenses for hotel and restaurant bars, is prohibited in any place of business located within five hundred (500) feet from any established church, or public or private school, other than a pre-kindergarten school, nursery school or day care center, or adult education center, measured from the main normal public entrance of the alcoholic beverage establishment to the nearest point of the church or school property used as part of such facility along public thoroughfares by the shortest route of ordinary pedestrian traffic. Whenever such a state license has been lawfully procured and thereafter a church or school is established within a distance otherwise prohibited by this section, the establishment of such church or school shall not be cause for the revocation of the state license or prevent the subsequent renewal of same.

(B) For dining rooms or restaurants where the sale and service of alcoholic or intoxicating beverages is incidental to the sale and service of food and for hotels with fifty (50) rooms or more, the board of adjustment is authorized to grant special exceptions to the distance requirements as established by (a) above where the board finds that such special exception will not be contrary to the public interests. The application for a special exception and the processing and hearing upon the application shall be in accordance with section 47-31.

Applicant must **POST SIGNS** (for Board of Adjustment) according to Sec. 47-27.2 Types of Public Notice and 47-27.9 Variance, Special Exception, Temporary Non-Conforming Use, Interpretation requires the following notice:

- Sign Notice shall be given by the applicant by posting a sign provided by the City stating the time, date, and place of the Public Hearing on such matter on the property which is the subject of an application for a development permit. If more than one (1) public hearing is held on a matter, the date, time, and place shall be stated on the sign or changed as applicable.
- The sign shall be posted at least fifteen (15) days prior to the date of the public hearing.
- The sign shall be visible from adjacent rights-of-way, including waterways, but excepting alleys.
- If the subject property is on more than one (1) right-of-way, as described above, a sign shall be posted facing each right-of-way.

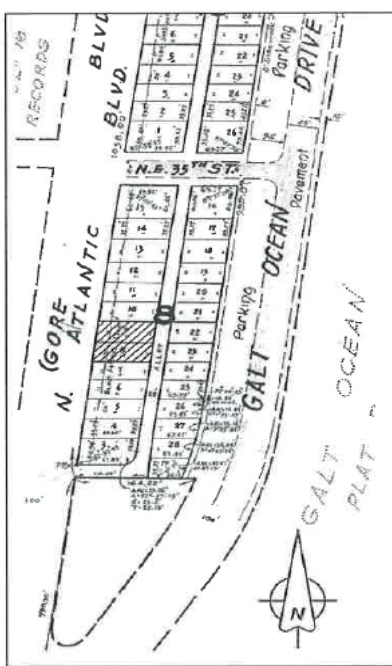
