Re: 2023 Mobility Advancement Program Project Application Rankings and

Recommendations for Broward County Surtax Municipal Capital Projects

On March 8, 2023, the City Commission adopted Resolution No. 23-51 endorsing New Municipal Capital Projects as a part of the 2023 Mobility Advancement Program Projects for Broward County Surtax Funding. Each municipality was allowed to submit up to three project applications and based on the program criteria, each application must either create a new roadway, expand a roadway or intersection, or implement traffic calming measures.

The City of Fort Lauderdale submitted the following applications:

- 1. NE 26th Street Complete Streets Project
- 2. SW 14th Avenue and Middle Street Project and
- 3. SW 19th Avenue and SW 20th Street New Road Construction.

In early July, the Broward Metropolitan Planning Organization (MPO) notified City staff that two of the three projects are being recommended for funding. The NE 26th Street Complete Streets Project and the SW 14th Avenue and Middle Street Project were recommended for design funding.

The five-year plan is tentatively scheduled for Surtax Oversight Board consideration on August 18, 2023, and if awarded, the projects will be programmed for design in 2028. These applications are for the design phase only and subsequent surtax application(s) for construction funding will need to be submitted for consideration in a future year.



¹ The actual amount of surtax funding an MCP is eligible to receive is determined by future reviews conducted by Broward County staff. The amount requested may not match the amount included in the Project Funding Agreement (PFA) for that phase, or subsequent phases, of the project.

² Minimum Annual Guarantee (MAG): County's funding commitment to utilizing at least ten percent (10%) of the Transportation Surtax Proceeds received by the County each Fiscal Year to fund, collectively, Community Shuttle Service, Municipal Capital Project (MCPs), Municipal R&M Projects, and Municipal Project Contingency, pursuant to the terms and conditions of the Second Amendment.

DEVELOPMENT STATUS OF PROJECTS




New MCPs requesting planning funds make up 18% of total recommended projects
