Re: Broward Commuter Rail South Public Information Meetings - December

4th & December 6th

On Monday, December 4<sup>th</sup> and Wednesday December 6<sup>th</sup>, Broward County and the Florida Department of Transportation will be holding public information meetings for the Broward Commuter Rail (BCR) South Project Development and Environment (PD&E) Study.

A PD&E study is the process to evaluate the social, economic, and environmental impacts associated with a planned transportation improvement project. The purpose of this project is to extend commuter rail service on the Florida East Coast (FEC) Railway corridor from the passenger station in the City of Aventura northward to the City of Fort Lauderdale, a distance of 11.5 miles. The stations are recommended in the City of Hollywood, Fort Lauderdale-Hollywood International Airport, and the City of Fort Lauderdale (near SE 17<sup>th</sup> Street).

The First Alternatives Public Workshop is scheduled for Monday, December 4, 2023 (inperson) and Wednesday, December 6, 2023 (virtual):



The Florida Department of Transportation (FDOT) and Broward County Transit have been alternatives for evaluating implementing commuter rail along the Florida East Coast (FEC) Railway from Aventura in Miami-Dade County into Broward County since January 2021. This evaluation is a direct result of a previous study known as the 'Coastal Link' that evaluated 85 miles of commuter rail in Miami-Dade, Broward, and Palm Beach Counties. On August 25. 2022, the Broward County Commission adopted a Locally Preferred Alternative (LPA) for Broward Commuter Rail South (BCR South) to extend commuter rail service on the FEC Railway corridor from the passenger station in the City of Aventura north to the City of Fort Lauderdale, a distance of 11.5 miles. Stations are recommended in the City of Hollywood, Fort Lauderdale-Hollywood International Airport, and South Fort Lauderdale. The South Fort Lauderdale station provides access to downtown Fort Lauderdale, Broward Health Medical Center, the Broward County Convention Center, Port Everglades, and the Beaches. Please note this project is independent and south of the New River in Fort Lauderdale. The Broward County Commission directed staff to pursue grant funding from federal and state government sources to support the project, and to coordinate with the Broward Metropolitan Planning Organization (MPO) and organizations as appropriate in seeking such grant funding.

On December 2, 2022, the U.S. Department of Transportation's Federal Transit Administration

(FTA) announced that the BCR South project was accepted into the Project Development (PD) phase. Entry into Project Development makes the project eligible for federal funding through the Capital Investment Grant (CIG) program of FTA and allows funds expended by Broward County Transit to count towards the local match requirements of a future federal grant. On February 9, 2023, the Broward MPO voted to amend the Metropolitan Transportation Plan (MTP) to include BCR South as a Priority I project within the fiscally constrained portion of the plan, with PD funding programmed and approved in 2022 by both Broward County and FDOT.

Miami-Dade County is also studying the implementation of commuter rail service in the FEC corridor from Downtown Miami to the Brightline Station in Aventura, known as the Northeast Corridor. The Northeast Corridor is in the Project Development phase with the Federal Transit Administration making it eligible to compete for federal funding.

Commuter rail stations are similar to SunRail stations in Central Florida and typically include:

- Platform (~500 feet long)
- Canopy
- · Bus Bays
- Ticket Vending Machines (TVM)
- · Schedule Information and Boards
- · Wayfinding Signs & Audio
- · Benches, Bike Racks, and Garbage Cans
- · Security Cameras
- Protection Railings
- · Stairs and ADA Ramps
- Parking

Pedestrian access bridges will be evaluated.

BCR South stations are proposed at:


- Hollywood (Dual Side Platforms)
- Fort Lauderdale-Hollywood International Airport (Center Platform)
- South Fort Lauderdale (Side Platform)
