**Re:** Intersection Improvement Project – SE 3 Avenue and SE 1 Street

---

The intent of this memorandum is to inform you of the upcoming intersection improvement project at SE 3 Avenue and SE 1 Street, anticipated to commence on April 16, 2024.

The project is managed by Broward County and includes:

1. Installation of new mast arm High-Intensity Activated Crosswalk Signal System
2. Upgrades of the existing pedestrian curb ramps
3. Milling and resurfacing
4. Signage and pavement markings

Work is planned to take place during daytime hours between 9am and 4pm. During the installation of the mast arm footings, a portion of SE 1 Street will be closed with a detour via SE 2 Street. County and City staff will coordinate closely and suspend work activities during any special events that may adversely affect mobility in this area.

Broward County's Office of Public Communications is performing public outreach, and the City's Strategic Communications team will supplement the outreach efforts.

The project is expected to be completed in July 2024.

Broward County is pleased to announce that construction will begin soon for the SE 3<sup>rd</sup> Avenue and SE 1<sup>st</sup> Street Intersection Improvement Project.

### Project Management:

Broward County is managing the contracting and construction of this project.

### Project Overview:

SE 3<sup>rd</sup> Avenue and SE 1<sup>st</sup> Street Intersection Improvement project that includes:

- New mast arm High-Intensity Activated Crosswalk (HAWK) Signal System Crossing at SE 3 Avenue with a traffic control cabinet and equipment such as pedestrian push button pedestals.
- Upgrades of existing pedestrian sidewalk and ramp to meet current ADA standards.
- Milling and resurfacing of the intersection asphalt pavement.
- Signing and pavement markings.

### Estimated Project Schedule:

Start construction work: April 16, 2024

End construction work: July 2024

During construction, contractor personnel & inspection staff will work closely with residents and businesses in the construction area to minimize impacts caused by the project.
