**Re: Full Closure of Broward Boulevard at Florida East Coast (FEC) Railway Grade Crossing**

The intent of this memorandum is to inform the City Commission of the upcoming full closure of Broward Boulevard at Florida East Coast (FEC) Railway crossing for scheduled highway-rail grade crossing rehabilitation performed by the FEC contractors.

The full closure is scheduled from Saturday, August 3, 2024, at 6:00 p.m. until Tuesday, August 6, 2024, at 11:59 p.m. If necessary, this closure will extend to Wednesday, August 7, 2024, at 11:59 p.m.

The primary detour routes for east-west traffic are Sunrise Boulevard to the north and Davie Boulevard to the south. Primary detour routes for north-south traffic are US-441/SR-7 to the west and US-1/SR-5 to the east.

FDOT District 4 Office of Public Communications is performing public outreach. The City's Strategic Communications team is supplementing the outreach efforts.

As announced in our email sent on July 17, 2024, the Florida East Coast (FEC) Railway will perform a highway-rail grade crossing rehabilitation project at SR 842/Broward Boulevard. The FDOT team closely coordinated with your staff on this roadway closure. The work will be performed by FEC contractors and workers to rehabilitate the existing track, to repair rails, and to replace the crossing surface to improve the resiliency of the corridor, the safety condition and the ride quality at the crossing for railway and roadway users.

This work will require a full closure at SR 842/Broward Boulevard from Saturday, August 3, 2024 at 6:00 p.m. to Tuesday, August 6, 2024 at 11:59 p.m. If necessary, this closure will extend to Wednesday, August 7, 2024 at 11:59 p.m.

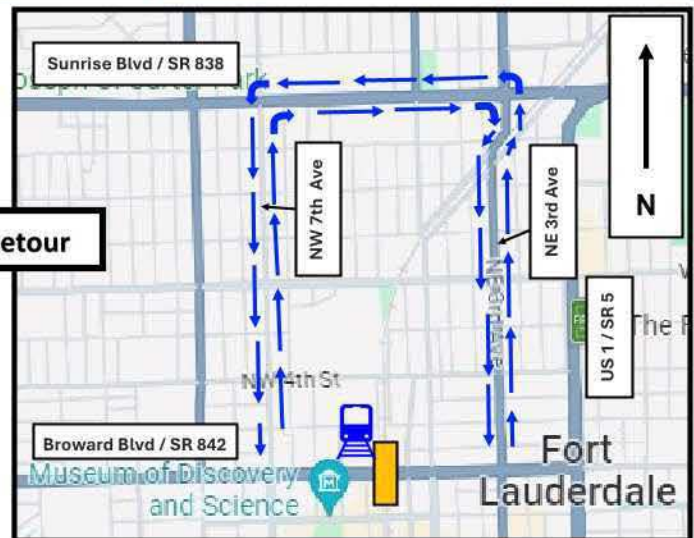
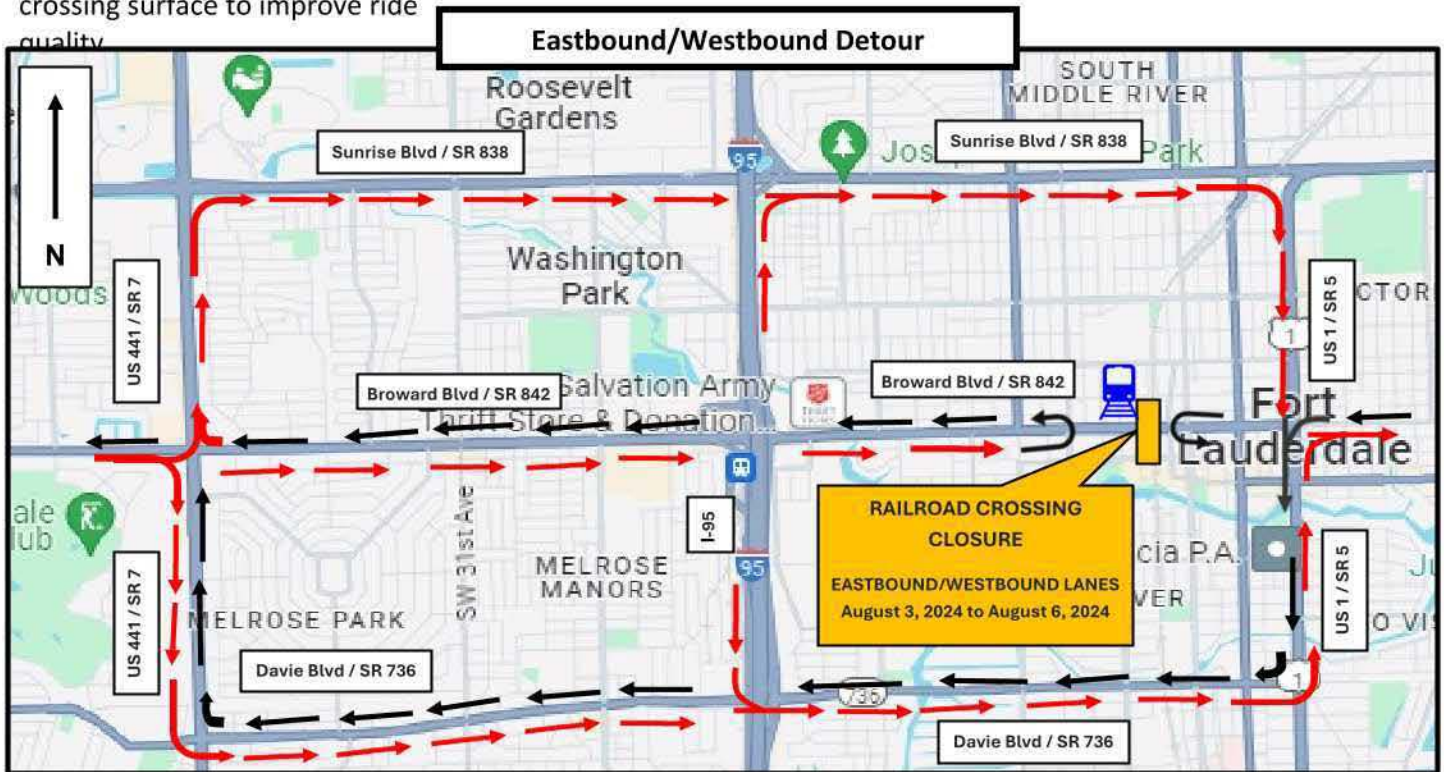
