Re: Upcoming Road Closures at Florida East Coast (FEC) Railway Grade Crossings

The intent of this memorandum is to inform the City Commission of the upcoming full closures at several Florida East Coast (FEC) Railway crossings for scheduled roadway - rail grade crossing rehabilitation performed by the FEC contractors.

The crossings require maintenance to restore acceptable level of surface conditions for both roadway and rail traffic. Locations and dates of closure are as follows:

- SW 2nd Street: from 6 p.m. on July 31 to midnight on August 2
- SW 9th Street: from 6 p.m. on August 5 to midnight on August 7
- SW 15th Street: from 6 p.m. on August 7 to midnight on August 9
- SW 17th Street: from 6 p.m. on August 11 to midnight on August 13

FEC contractors will install signage and establish detours for each closure. The City's Strategic Communications team is conducting outreach efforts.
