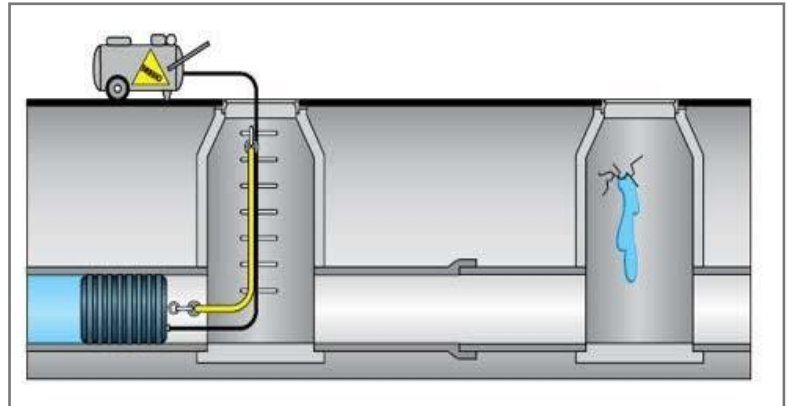




INFLOW & INFILTRATION REDUCTION PROGRAM: OVERNIGHT WASTEWATER FLOW ANALYSIS

The City of Fort Lauderdale is working with Ardurra Group Inc. to study the flow of wastewater throughout the City's sewer system over the next three years. This flow analysis is part of the City's ongoing efforts to identify portions of the sewer system where stormwater and groundwater are possibly entering the system, which leads to problems such as increased treatment cost and reduced system capacity. The results of this analysis will be used to plan future sewer system improvement projects.



This work began on Sunday, July 21, 2024, and the current phase is expected to be completed in November 2024. This schedule is subject to change based on inclement weather or other unforeseen circumstances. Inspections will take place Sunday through Thursday evenings between 11 p.m. and 7 a.m. During this time, most neighbors are sleeping, meaning that flows in the system are likely due to infiltration of groundwater or stormwater through defective sewer pipes and structures.

Crews will be accessing sewer lines through sewer manholes. Therefore, no heavy machinery will be on site and minimal noise and lighting impacts are expected.
