Re: Removal of Traffic Signal Mast Arms at State Road A1A and Vistamar Street

The intent of this memorandum is to inform the City Commission of the upcoming removal of the traffic signal mast arms at the intersection of State Road A1A and Vistamar Street.

On September 9, 2024, City staff received notification from the Florida Department of Transportation (FDOT) that a routine structural inspection was recently performed on the traffic signal mast arms at the intersection of State Road A1A and Vistamar Street. The inspection resulted in plans to remove both traffic signal mast arms by Thursday, September 12, 2024.

Portable traffic signals will be deployed and operational by Wednesday, September 11, 2024. All existing traffic and pedestrian patterns will be maintained under this temporary condition. The portable traffic signals will remain in place until a temporary span wire traffic signal system is designed and installed which is anticipated for 2025. Ultimately, all the mast arms at this intersection will be permanently replaced as part of a future construction project scheduled for March of 2026.
